1. Purpose:

- a. This publication scheme was provided by the DfE having been prepared and approved by the Information Commissioner

- c. The classes of information will not generally include:
 - 1. Information the disclosure of which is prevented by law, or exempt under the Freedom of Information Act, or is otherwise properly considered to be protected from disclosure.
 - 2. Information in draft form.
 - 3. Information that is no longer readily available as it is contained in files that have been placed in archive storage, or is difficult to access for similar reasons.
- d. This scheme contains details of:
 - 1. The method by which information published under this scheme will be made available
 - 2. What information is covered by this scheme and how it can be obtained.
- e. Where possible information will be provided on the website. - g. Information will be provided in the language in which it is held or in such other language that is legally required. Where the school is legally required to translate any information, it will do so.
- h. Obligations under disability and discrimination legislation and any other legislation to provide information in other forms and formats will be adhered to when providing information in accordance with this scheme.

3. Charges which may be made for Information published under this scheme

- a. The purpose of this scheme is to make the maximum amount of information readily available at minimum inconvenience and cost to the public. Charges made by the school for routinely published material will be justified and transparent and kept to a minimum.
- b. Material which is published and accessed on a website will be provided free of charge.
- c. Charges may be made for information subject to a charging regime specified by Parliament.
- d. Charges may be made for actual disbursements incurred such as:
 - photocopying

 - the costs directly incurred as a result of viewing information
